ACCOMMODATION IN A BOARDING SCHOOL IN UDINE

We inform you that at the end of the period of allocation of accommodation places provided for in Article 33 of the ARDIS Public notice, all university residences in the region will be closed in August 2023 for maintenance, cleaning and sanitizing works. To those Students, assigned for accommodation (therefore with income and merit requirements) for the year 2022/2023) for the academic year 2022/2023, unable to return to their own residences on August, ARDIS offers accommodation in a boarding school placed in Udine, from 01/08/2023 to 01/09/2023.

Students must leave their residences on 01/08/2023, by 9.00 am.

Students interested in using accommodation in the boarding school in Udine, that will be identified shortly, must request accommodation for the month of August 2023 by completing the attached form and sending it strictly no later than 8th JUNE 2023 exclusively to the accommodation mail addresses: alloggi.udine@ardis.fvg.it or alloggi.trieste@ardis.fvg.it, depending on your ARDIS operational headquarters of reference. Applications sent within the times and methods indicated above can be satisfied until all available places are exhausted. Only single or double rooms for single use will be assigned.

The monthly cost is € 218.00 to be paid to ARDIS through the payment system PagoPA, indicating as the reason "Accommodation fee for the month of August 2023 boarding school Udine".

The importance of respecting the above mentioned deadline is underlined as the numbers that ARDIS will communicate to the boarding house after will be considered definitive.

In case of non-payment and transmission of the relative payment certificate within the communicated terms the application for use of the accommodation will not be taken into consideration.

LUGGAGE DEPOSIT

We inform you that during the summer closing period, the assignee of an accommodation who does not have the possibility to store his/her personal effects removed from the room at the end of the assignment period, can use the luggage storage service according to the rules published on the ARDIS website at the link <http://www.ardis.fvg.it/contenuti.php?view=page&id=213#scheda726>

Students who will be assigned accommodation for the month of August will autonomously reach boarding house in Udine that will be identified and communicated shortly. Personal baggage deemed unnecessary for this period can be deposited in the warehouse relating to the residence of departure according to the rules indicated in the aforementioned notice.
