- Failure to sign the act of acceptance of the accommodation within one month from the date of the scheduled admission indicated by ARDiS will entail the loss of the benefit pursuant to Article 32 of the Ardis Single Call for the academic year 2024/2025 unless there are proven reasons of force majeure or the participation in outgoing mobility program. I will, therefore, be required to pay the accommodation fee for the period during which the room will be reserved for me, starting from the scheduled admission day;
- The deduction from the scholarship for the accommodation service is calculated from the date of admission indicated in the Ranking results section in my personal area called "student desk".

- If I am not a scholarship beneficiary for the academic year 2024/2025, I will pay the accommodation service according to the fees indicated in the call.
