COMMUNICATION OF THE ALLOCATION OF ACCOMMODATION PLACES IN THE STUDENT HOUSES OF THE ARDIS CENTRES IN TRIESTE AND UDINE FOR STUDENTS WITH THE REQUIREMENT OF ENROLMENT ONLY ACCORDING TO ART. 38 OF THE ARDIS' SINGLE CALL FOR APPLICATIONS FOR THE A.Y. 2024/2025

With reference to the Call approved by Ardis Decree no. 2473/24 and integrated by Ardis Decree no. 1/25, it is hereby communicated that the processing of the applications completed and finalised by 10/01/2025 has shown a number of eligible students lower than the number of available accommodation places.

Therefore, pursuant to art. 38 of the Single Call for the allocation of regional benefits for the academic year 2024/2025, it is not necessary to define the relative rankings.

Find attached Ardis' Decree no. 44 of 15/01/2025 recognising the above-mentioned applications finalised by the deadline of 10/01/2025.

Students who are indicated as beneficiaries in the annexes to the above-mentioned decree, are assigned the available accommodation places starting from 16/01/2025 (or from the date of entry indicated in the application, if later) and receive by 15/01/2025 a specific communication by email with the number of the assigned room and the building as well as the amount of the accommodation fee and the deposit due.

Please note that any student who, for whatever reason, is not able to take possession of the accommodation assigned on 16/01/2025 (or on the date of admission indicated in the application, if later) must send no later than the date of admission, to the address alloggi.trieste@ardis.fvg.it or alloggi.udine@ardis.fvg.it depending on the reference location, the postponed admission form (available as attachment), which must be accompanied by proof of payment of the security deposit as per art. 35 of the Ardis Announcement. Late admission forms that are not accompanied by the proof of payment of the security deposit will not be taken into consideration. Students who do not present themselves to take possession of the accommodation on the date communicated and who do not send the appropriate postponed admission form by that date shall forfeit the accommodation place.

On entering the Student House, the assignee of the accommodation must must submit the following documentation to the Reception staff:

- 1. legible photocopy of a valid identification document (accompanied by the original document). Non-EU students must present themselves with a passport or other recognised identity document;
- 2. proof of payment of the security deposit referred to Article 35 of the current Ardis' Single Call, the amount of which corresponds to a monthly accommodation fee. The amount of the rent fee is communicated with the abovementioned email;
- 3. original receipt of the online application duly stamped;
- 4. a passport photo.

Failure to produce the documents referred to in points 1, 2 and 3 will result in the inability to access the accommodation..

Applications completed after the deadline of 10/01/2025 and in possession of the requirements, if received by 10/05/2025, will be processed for further examination. An accommodation will be granted, in the event of availability and in compliance with the principle of non-promiscuity of gender, according to the chronological order in which the application was completed.

The provisions contained in the aforementioned Call approved by Ardis Decree no. 2473/24 and supplemented by Ardis Decree no. 1/25 find application.
